KidLead Certified Trainer Agreement

While Certified Trainers are acting as independent agents, we do expect them to comply with this agreement if they are to retain their certification, which gives them the right to use the KidLead curriculum and communicate themselves as a KidLead Trainer. Failure to comply with this agreement will result in nullifying your right to use the KidLead name and curriculum and may result in appropriate legal action. This is the *pre-agree* prior to formal training, but we'll ask you to sign the same agreement at the end. We want you to have a sense of what you're agreeing to as well as preserving KidLead's training content.

1. I agree to use the curriculum as scripted.
2. I agree to use the KidLead programs' logo's and if I prefer to combine it with our own, will confer with KidLead in the process. *
3. I agree to provide KidLead with Leader Applications and SIS forms of those accepted, as well as post-tests for its research (within 90 days following completion of 4th module).
4. I agree to require every Koach have basic training including a background check and pay the Koach fee to KidLead.
5. I agree to pay KidLead the materials-application fee for every participant per module.
6. I understand that KidLead materials are copyrighted and agree not to use these or allow others to do so, outside of a KidLead training program.** Because of international agreements, this use is limited to the United States without written permission otherwise.
7. I agree to provide participant/parent feedback with KidLead to best of ability within 90 days of ending a module.
8. I agree not to use the KidLead material if my certification lapses. I realize that if I do not lead a club within 2 years of this training, I will need to be re-certified incurring 50% of expenses related to the application and training fee
9. I grant permission to KidLead Inc. to conduct updated background checks and acknowledge that from time to time a representative from the organization may review my performance and provide additional training recommendations.
10. I realize that I am not certified until I've finished leading 1 training module on my own or with a co-trainer.
